

# Scout Jam 2010 Video Contest

**Theme Categories** (Enter in one, two, three or all four categories)

**Preparing for Scout Jam**  
**(Why) It's A Great Day To Be A Scout**  
**Celebrating Scouting's 100<sup>th</sup> Birthday**  
**Air Guitar (to "Don't Stop Believing" by Journey)**

**Maximum length:** 3 minutes

(Entries may be used in the Saturday night Show, at the Scout Jam Film Festival and/or a workshop on video production.)

## Rules for Most of Us

- 1. Eligibility:** Any registered Scout or Scouter in the US. Void elsewhere and where prohibited by law.
- 2. Submission Period:** No later than January 31, 2010
- 3. How to Enter:** Send disk to: Scout Jam Video Contest, c/o Randy Segler, PO Box 15655, Panama City, FL 32406. Or bring it to Green Bar Training. Include a parent or legal guardian's e-mail address so we can confirm that you have permission. If you don't, we may reject your entry.
- 4. Entry Requirements:** In order to be entered in the Contest, the video must be in one of the following formats: .avi, .mov, .qt, .mp4, .mpeg, .wmv, .mpg, .mp3.
  - Do NOT include personally identifiable information such as last names, addresses, e-mail addresses, URLs or YouTube channel addresses.
  - Get written permission from anyone in the video.
  - No obscene, lewd or inappropriate images or text. We get to decide. We may reject your entry if it is not appropriate.
  - Don't copy any third party materials, or any copyright, trademark, logo, mark that identifies a brand or other proprietary right of any person living or deceased.
  - Don't make someone or some product look bad because they might sue us (and you).
  - Don't get hurt or hurt anybody or anything in the video. If you do, your entry will be disqualified.
  - Do make the Boy Scouts look good. Keep it positive.
  - We get to decide if your entry qualifies and your entry becomes ours. We can use it any way we want (but will do so responsibly...come on...we're Boy Scouts). By entering, you give up any rights you may have to the Entry submitted.
- 5. Winners:** Winners will be announced at Scout Jam 2010.
- 6. Prizes, Approximate Retail Value ("ARV") & Odds:** Prizes consist of bragging rights in perpetuity and a \$25 gift card for the winner in each category. Odds of winning any prize depend on the number of entries received.
- 7. Privacy information:** For Scout entries we need contact info for your parent or guardian. We will only use it to confirm they are ok with your entry(ies). Contact information will be destroyed at the conclusion of the promotion.
- 8. General Rules:** All federal, state and local laws apply. And you agree to play by the rules above.
- 9. Waiver:** If you enter, you agree not to sue us...ever...for anything (related to the video entry).

## Rules for Readers of Very Small Print

1. **Eligibility:** The Scout Jam Video Contest (the "Promotion") is open only to legal residents of the 50 United States and the District of Columbia, who are registered Cub Scouts, Boy Scouts, Varsity Scouts or Venturers and located in the U.S. at the time of entry. Void elsewhere and where prohibited by law.

2. **Submission Period:** The submission period begins at 12:01 a.m. Eastern Time ("ET") on December 1, 2009 and ends at 11:59 p.m. ET on January 31, 2010 (the "Submission Period").

3. **How to Enter:** Send disk to: Scout Jam Video Contest, c/o Randy Segler, PO Box 15655, Panama City, FL 32406. Or bring it to Green Bar Training.

A parent or legal guardian's e-mail address is required during registration. The parent or legal guardian will receive a confirmation email from the Sponsor, informing the parent/guardian of the Entrant's submission and giving the parent or legal guardian the opportunity to approve the Entrant's participation in the Contest. If the Entrant's parent/legal guardian does not notify the Sponsor of his/her approval of the Entrant's participation in the Contest before the end of the submission period, and/or does not agree to be bound by the Official Rules, then the Video Submission will be disqualified and the Entrant will not be entered in the Contest.

4. **Entry Requirements:** In order to be entered in the Contest, Entrants must comply with registration instructions when submitting their video. The video must be in one of the following formats: .avi, .dv, .mov, .qt, .mp4, .mpeg, .3gp, .asf, .wmv, .mpg, .mp3.

The Entry must NOT contain personally identifiable information such as last names, addresses, e-mail addresses, URLs or YouTube channel addresses. Entrants must obtain a signed release form from each person (or their legal guardian if under 18) who appears in the video. Entrants may be required, at any time, to provide Sponsor with evidence of all such releases, written permission(s) and authorization(s). By entering, you understand that your entry may (in Sponsor's sole discretion) be posted online for readers to view and vote on. In the event of a dispute as to the identity of an Entrant, the Entrant will be deemed the legal owner of the e-mail address appearing on the Entry. Limit one Entry per person/e-mail address. Any person who attempts to enter more than once will be disqualified.

The Entry may not contain obscene, lewd or inappropriate images or text, as determined in Sponsor's sole discretion. Any Entry Material or portion thereof that is, in the Sponsor's sole discretion, obscene, profane, lewd, defamatory, contains any third party materials, or otherwise violates or infringes (or may infringe) any copyright, trademark, logo, mark that identifies a brand or other proprietary right of any person living or deceased (including but not limited to rights of privacy or publicity or portrayal in a false light) or entity, or is otherwise objectionable, will not be considered and may disqualify the Entrant. Entrants may not copy or otherwise plagiarize the Entry Material from any source. Sponsor has the sole discretion to determine whether a video qualifies as an Entry. All Entries must be the sole, original work of the Entrants. Entries become the property of the Sponsor and will not be acknowledged or returned. Entrants and winners acknowledge and agree that their Entries become the property of the Sponsor, which thereby has the right to edit, adapt, modify, reproduce, promote and otherwise use Entries in any way it sees fit. Automated, script, macro or robotic Entries submitted by individuals or organizations will be disqualified. If, in Sponsor's sole discretion, the Entry appears to have resulted in any injury or bodily harm, it will be rejected. Entries must be in keeping with Sponsor's image and may not be offensive, as determined by Sponsor in its sole discretion, nor can it defame or invade publicity rights or privacy rights of any person, living or deceased, or otherwise infringe upon any person's personal or proprietary rights. In such an event, the Entry will not be posted online and will be disqualified from the Contest. Any Entry not in compliance with the above and does not meet the Websites' requirements will be disqualified. By entering, you agree to waive any rights you may have to the Entry submitted.

5. **Winners:** Winners will be announced at Scout Jam 2010.

6. **Prizes, Approximate Retail Value ("ARV") & Odds:** Prizes consist of bragging rights in perpetuity and a \$25 gift card for the winner in each category. Odds of winning any prize depend on the number of entries received.

7. **Privacy information:** Online contact information will be collected from entrants for the sole purpose of contacting parent or guardian for approval of the Entry, and for a direct one-time response to contact winner. Contact information will be destroyed at the conclusion of the promotion.

8. **General Rules:** All federal, state and local laws apply. By participating, participants agree to release, discharge and hold harmless Promotion Parties from and against any and all liability or damages associated with this Promotion or acceptance, use or misuse of any prize received in this Promotion.
